#### Yale School of Management Executive Education

#### 1. Introduction; Changes

Please read these Terms of Use and the other Agreements described immediately below before registering for, accessing or using any portion of the applicable program website(s) of Yale School of Management Executive Education online program(s) (collectively, the "Site," which consists of all content and pages located within and accessible on or through such website(s)) or any other websites, applications, programs or online products or services associated therewith (collectively, the "Services"). The term "Services" includes the Site and all content and pages located within and accessible via the Site, as well as any program material, program or cohort pages and platforms, information, directories and other electronic services available via the Site or any of the other Services. These Terms of Use, our Privacy Statement, and any Program-specific terms and conditions, requirements and/or guidelines are agreements (collectively, the "Agreements") made between you and Yale University. By registering for, accessing or using any Services, you accept and agree to be legally bound by the Agreements, whether or not you are a registered user or have an account. If you do not understand or do not wish to be bound by the terms of the Agreements, do not register for, access or use any Services.

We may make changes to the Agreements at any time, but will communicate any material changes to you by giving notice via the Services or by some other means. By registering for, accessing or using any Services after any changes have been made, you thereby agree to any such modified Agreements and all of the changes, which will be effective immediately unless we notify you of a later effective date. If the changes are not acceptable to you, you should discontinue use of the Services.

As used in these Terms of Use, "we," "us" and "our" refer to Yale University acting by and through the Yale School of Management.

#### 2. Programs

Through the Services, Executive Education at Yale School of Management offers online courses, programs or other offerings on particular topics (each, a "Program"). We reserve the right to cancel, interrupt or reschedule any Program or modify its content as well as the evaluation of progress that may be provided in connection with any Program. Programs are subject to the Agreements, including without limitation the Warranty Disclaimer and Limitation of Liability sections below.

You will not receive academic credit from the Yale School of Management or Yale University for registering or participating in a Program. Admission to the degree programs of the Yale School of Management and Yale University is separate from being registered in and/or taking one or more Programs. You agree and acknowledge that nothing in these Terms of Use or otherwise with respect to your access or use of any of the Services or any Program: (a) enrolls or registers you in the Yale School of Management, or any other school, division, center, institute or program of or associated with Yale University nor (b) entitles you to access or use university resources or receive any benefits or privileges of any of the foregoing beyond the Programs.

Yale School of Management Executive Education may offer written acknowledgment for participants who have satisfactorily demonstrated completion of the Program. The decision to provide such an acknowledgment to a given participant will be solely within our discretion. We may choose not to offer any acknowledgment for some Programs. In addition, we may decide in our sole discretion whether to provide a record concerning a participant's performance in a Program. The format of any such acknowledgment, and of any such record of performance, relating to the Programs will be determined in our sole discretion and may vary from Program to Program.

#### 3. Conduct

You agree that you are responsible for your own use of the Services and for your User Content, as well as any content of others that you submit, post, contribute, publish or distribute in connection with any of the Services. "User Content" includes all content, in whatever format, submitted, posted, contributed, published or distributed on any of the Services by a participant or other user, including but not limited to all notes, questions, answers, comments, text, pictures, videos and file uploads. In some Programs, participants may contribute by speaking or appearing on camera, and User Content may include transmissions or recordings of a participant's voice and/or image. You agree that you will use the Services in compliance with the Agreements and all applicable local, state, national and international laws, rules and regulations, including privacy, copyright and trademark laws, any laws regarding the transmission of technical data exported from your country of residence, and all United States export control laws.

THE FOLLOWING KINDS OF CONTENT ("PROHIBITED CONTENT") ARE STRICTLY PROHIBITED ON THE SERVICES:

1. Content that defames, harasses, discriminates against, harms or threatens others;

2. Content that discusses illegal activities, with the intent to commit them;

3. Content that violates privacy rights;

4. Content that infringes and/or misappropriates intellectual property or other proprietary rights;

- 6. Profane, pornographic, obscene, indecent or unlawful content;
- 7. Advertising or any form of commercial solicitation;

8. Content related to partisan political activities; and

9. Content that contains intentionally inaccurate information or that is posted with the intent of misleading others.

We reserve, in our sole discretion, the right to remove Prohibited Content of which we become aware, but are under no obligation to do so.

In addition, you agree not to: (a) use any of the Services in any manner intended to damage, disable, overburden or impair any part of any of the Services or the computer equipment or network(s) connected to any of the Services or to disrupt or interfere with any Program or any other user's use and enjoyment of any of the Services; (b) attempt to gain unauthorized access to any of the Services, other accounts, computer equipment or networks connected to any of the Services through hacking, password mining or any other means; (c) obtain or attempt to obtain any materials or information on or via any of the Services not intentionally made available through the Services; (d) copy or use any portion of any of the Services other than as expressly allowed under the Agreements; (e) use any high volume, automated, or electronic means to access any of the Services (including without limitation robots, spiders or scripts); (f) frame any of the Services, place pop-up windows over its pages, or otherwise affect the display of its pages; or (g) force headers or otherwise manipulate identifiers in order to disguise the origin of any communication transmitted through any of the Services.

If you participate in any Program, you agree to complete all work, including any quizzes and exams, associated with each such Program in which you are registered with only your own, original work, and you agree not to engage in any activity that would dishonestly or fraudulently improve your results or improve or hurt the results of others. In addition, unless otherwise stated in the respective Program, you agree that any exams, quizzes or questions provided in connection with each Program are for your individual, personal use only. Copying, capturing,

transmitting or providing all or any part of the exams, quizzes, questions or any other Program materials to any other person is strictly prohibited. We reserve the right to immediately terminate your participation in any Program and pursue any and all legal remedies against you if you violate the Agreements.

#### 4. User Accounts and User Registration

In order to participate in most Services, you must register for a personal account on the relevant Service (a "User Account") by providing an email address and a password for your User Account, as well as any additional information required herein or on the relevant Service. If a Program is offered via the Site, participants in the Program may not be required to register for a User Account. Instead, we may choose to provide such participants with separate authentication credentials necessary to register for and access the Program (a "Login Credential"). You agree that you will never divulge or share access or access information to your User Account or Login Credential with any third party for any reason. You also agree that you will create, use, and/or access only one User Account or Login Credential, and that you will not access the Services using any User Account or Login Credential other than your own.

As part of your registration in a Program(s), you may be required to submit a headshot photo of yourself (via webcam or such other method as we may require). Your registration and participation in the Program(s) will be contingent upon successful completion of applicable ID screenings, including but not limited

to restricted party screenings, which may be performed by our third-party service providers.

#### 5. License Grant to You; Intellectual Property Rights

In consideration for your agreement to these Terms of Use, we grant you a personal, non-exclusive, non-transferable, revocable license to access and use the Services solely in accordance with the Agreements. We may make Program Content (as defined below) available to you through the Programs or otherwise via the Services. You may obtain and use Program Content only for your own personal, noncommercial use in connection with the Services and participating in Programs. You may only copy and modify Program Content as necessary for your own personal, noncommercial use. You may not transfer, retransmit, distribute, broadcast, publish, alter, commercially exploit or create derivative works of any Program Content, in whole or in part. You may not reverseengineer, decompile, disassemble or otherwise access the source code for any software that may be used to operate any of the Services. Notwithstanding the foregoing, certain reference documents, digital textbooks, articles and other information on the Services may be made available to you with the permission of third parties, and use of that third party material may be subject to certain rules and restrictions of the rightsholder. No trademark or service mark appearing on the Services may be used without the prior written consent of the mark's owner. You may not use any Marks without valid, written authorization from Yale University. Additionally, you may not use any Marks in any manner that (a) will likely cause confusion about the source of any product or service or (b) falsely implies or represents that we sponsor, endorse, or are affiliated with any activity that we did not authorize.

We and/or our affiliates and licensors reserve all rights not expressly granted herein to the Programs, Services, Program Content, and Marks.

#### 6. User Submissions

The Services may provide you with the ability to upload or otherwise provide certain User Content. With respect to User Content you submit or otherwise make available in connection with your use of the Services, and subject to the Privacy Statement and applicable confidentiality obligations, you grant Yale University a fully transferable, worldwide, perpetual, royalty-free and nonexclusive license to use, reproduce, modify, adapt, make derivative works of, distribute, publicly perform, publicly display and otherwise disseminate and make available such User Content, in any manner or medium now known or later developed, and to authorize others to do any of the foregoing. You expressly acknowledge that your User Content may be visible to others and may include Personally Identifiable Information, as defined in the Privacy Statement. To the extent that you provide User Content, you represent and warrant and agree that (a) you have all necessary rights to provide and use such User Content and permit Yale University to use such User Content as provided above; (b) as between you and us, you shall be responsible for the payment of any third party fees related to the provision and use of such User Content; and (c) such User Content does not and will not infringe or misappropriate any third party rights.

In connection with your participation in a Program, you may have the ability to access or download User Content of other users taking the Program and other users may have the ability to access or download your User Content. While we require all users to comply with these Terms of Use and the Privacy Statement in providing User Content, we cannot guarantee such compliance or that any such User Content will be free of Prohibited Content, viruses, worms, back doors, Trojan horses or other harmful contaminants. Yale University disclaims any responsibility or liability relating to your access or download of any and all User Content.

The Services may also provide you with ability to upload or send information to us regarding the Services ("Feedback"). By submitting Feedback, you hereby grant Yale University an irrevocable license to use, reproduce, modify, adapt, make derivative works of, distribute, publicly perform, publicly display and otherwise disseminate and make available such Feedback, in any manner or medium now known or later developed, and to authorize others to do the foregoing.

You acknowledge that we may screen User Content, and that we shall have the right (but not the obligation), in our sole discretion, to remove any User Content without any liability to you. Without limiting the foregoing, we have the right to remove any User Content that violates the Agreements or is otherwise objectionable in our sole and absolute discretion. You agree and acknowledge that we may preserve User Content and may disclose User Content if required to do so by law or in the good faith belief that any such preservation or disclosure is reasonably necessary to comply with legal process, enforce these Terms of Use, respond to claims that any User Content violates the rights of third parties, or protect our rights, property or personal safety or that of our Users and the public.

# 7. Payment

Unless we otherwise expressly agree in writing, full payment for participation in a Program is required at the time of registration or as indicated on your invoice, whichever is applicable. Specific payment requirements and related terms and conditions may be provided to you at the time of registration on the applicable Program-specific website or otherwise on the applicable Service.

#### 8. Refunds

If you withdraw your registration before the start of a Program, you may be eligible, in our sole discretion, for a refund of all or part of paid Program fees, minus a processing fee. <u>Please see the applicable refund policy here</u>. If you withdraw after the start of the Program, or if you are found to be in violation of any of the Agreements or any other Yale University or Program-specific policies or guidelines, you will not be issued a refund unless we elect to do so.

If your participation in a Program is governed by a current agreement between Yale University and your employer or a sponsoring entity, the terms and conditions of such agreement will govern payment and refunds to the extent they differ from those set forth herein.

#### 9. Termination of Services

You agree that Yale University, in its sole discretion, may terminate your use of any or all of the Services or your participation in any Program, for any reason or no reason, and that Yale University shall not have any liability to you for any such action; provided, however, that if we terminate your participation in a Program other than for cause (including, without limitation, your failure to comply with any term of the Agreements), you will receive a pro-rata refund of any fees you paid in connection with the Program. Without limiting any of Yale University's other rights or remedies, it is the university's policy to terminate in appropriate circumstances users of the Services who are repeat copyright infringers or who violate the provisions set forth in Section 3. Conduct. We will not be required to provide you any service or engage in any activity (including but not limited to providing you with any Program content or materials and/or Program acknowledgements relating to same) if we believe in our sole discretion that the service or activity may violate any applicable law or regulation. You further acknowledge that for the purpose of your participation in any Program your relationship with Yale University is as defined in the Agreements. Termination does not give rise to any right to any grievance or other resolution process for student disputes at the Yale School of Management, or any other school, division, institute or program of or associated with Yale University. You agree that we have the right to cancel, delay, reschedule, or alter the format of any Program at any time. If you no longer wish to participate in any Program or use any of the Services, you may terminate your participation upon written notice to Executive Education at the Yale School of Management. All of the rights and licenses granted to you hereunder will automatically terminate upon any termination or expiration of your right to use the Services or your participation in a Program, but all other provisions of the Agreements will survive any such termination or expiration. No termination or expiration of any of the Agreements shall affect any liabilities that may have accrued prior to such date.

#### 10. Links

The Services may include hyperlinks to websites or applications maintained or controlled by others. Yale University is not responsible for and does not routinely screen, approve, review or endorse the contents or use of any of the products or services that may be offered at these websites or applications. If you decide to access linked third-party websites or applications, including without limitation the websites or applications of our payment processors, you do so at your own risk.

# 11. Eligibility

Account registration and participation in any Program or other Service is generally restricted to those individuals 18 years of age or older who are fully able and competent to enter into the terms, conditions, obligations, affirmations, representations and warranties herein. By registering for or participating in a Program or Service, you hereby represent and warrant that you are 18 years of age or older and have the authority and legal capacity to enter into the Agreements. You consent to the personal jurisdiction of those courts over you for this purpose, and you waive and agree not to assert any objection to such proceedings in those courts (including any defense or objection of lack of proper jurisdiction or venue or inconvenience of forum).

You agree to indemnify and hold harmless Yale University (as defined for this purpose in Section 13 above) from any and all claims, liabilities, damages, losses and expenses, including reasonable attorneys' fees and costs, relating to or arising out of (a) your use or attempted use of any of the Programs or other Services in violation of any of the Agreements; (b) your violation of any law or rights of any third party, including without limitation any claim of infringement or misappropriation of intellectual property, privacy, right of publicity and/or other proprietary rights; and/or (c) any information or content that you post or otherwise make available through any Program or otherwise via any of the Services.

# 15. Copyright Notices

We intend that all information and content on the Site respect the copyright and other proprietary rights of third parties. With respect to any copyrighted material owned by third parties, we have obtained permission to use such content from the copyright owner or have proceeded with use as otherwise permitted under U.S. copyright law. These Terms of Use and the other Agreements together constitute the entire agreement between you and Yale University with respect to your use of the Services, superseding any prior agreements and understandings between you and Yale University regarding your use of any of the Services.

# 17. Assignment

We may freely transfer or assign any portion of our rights or delegate its obligations under the Agreements. You may not transfer or assign, by operation of law or otherwise, any portion of your rights or delegate your obligations under the Agreements without our prior written consent, and any attempted such transfer or assignment shall be void and of no effect.

#### 18. Waiver

The failure of Yale University to exercise or enforce any right or provision of the Agreements shall not constitute a waiver of such right or provision. If any provision of the Agreements is found by a court of competent jurisdiction to be invalid, the parties nevertheless agree that the court should endeavor to give effect to the parties' intentions as reflected in the provision, to the extent that may lawfully be done, and the other provisions of these Terms of Use shall remain in full force and effect.
